## SCORING & REPORTING LICENSES

Licenses are issued under our copyright and other proprietary rights to permit the copying or other reproduction, transcription, recording, storage, and retrieval of Questar's published and unpublished Proprietary Data (e.g., answers, raw score to scale score or standard score conversion tables, norms, scoring and reporting decision rules, reporting formats, tables, statistical algorithms, and grouping rules) for the purpose of scoring, reporting, and analysis by hand or computer. Questar's Proprietary Data may not be otherwise published, reproduced, divulged, disseminated, or used, in whole or in part, in any manner or format.

**Royalty-Free Scoring & Reporting Licenses.** Class A and Class B Licenses are provided to schools and other educational entities to score and report DRP, SSSMART, RPE, and MAC II test results for their own students. Neither the Class A nor the Class B royalty-free, non-transferable license charges a per-student fee for the

use of Questar's Proprietary Data. Because our policy of issuing royalty-free licenses to schools and other educational entities that purchase or license DRP, SSSMART, RPE, and MAC II products is under continuous review, Questar reserves the right to revoke it at any time, but only after reasonable prior notice.

A **Class A License** allows schools/districts to produce raw scores for their own students by hand. A Class A License also allows the royalty-free use of copyrighted data when producing, by hand, reports with DRP, SSSMART, RPE, or MAC II Scores and/or national normative data. To obtain a Class A License, check the appropriate box on the Materials Order Form.

A **Class B License** allows schools/districts to use computers to score and report DRP and MAC II test results. A custom Questar Tables CD containing Questar's Proprietary Data must be purchased. The disk is customized to provide data for the particular tests administered in a school or district, and reduces the possibility of making errors when using Questar's Proprietary Data. **Royalty-Bearing Scoring & Reporting Licenses.** Our licensing policy requires that all organizations (except school systems) and all individuals performing scoring, reporting, or analysis by hand or computer for DRP or MAC II instruments, obtain and sign a **Class C License** bearing a royalty charge for processing DRP or MAC II answer documents or licensed alternatives. Organizations and individuals ordinarily required to obtain and sign the license on a royalty basis include those providing hand or computer scoring, reporting, or analysis services for DRP or MAC II tests to others, whether or not a fee is charged. Notice: Schools and districts using third-party scoring centers are responsible for checking that the scoring center is properly licensed to provide scoring and reporting for Questar's tests and has obtained a Questar Tables CD for the DRP or MAC II test forms being used to ensure accurate, uniform reporting of test results. Customers may call or write Questar for verification that a scoring center is properly licensed and has the data required by the school system.
